# 6th AFSEC General Assembly -Abidjan, Côte d'Ivoire

The NEC of Côte d'Ivoire hosted the 6<sup>th</sup> AFSEC GA, in Abidjan 17-19 July 2018. In addition to the election of new Vice Presidents for the term 2019-2022, several other important resolutions were approved, notably the introduction of the concept of 'partner organizations' and approval of 26 IEC standards newly recommended for common adoption by several of the AFSEC technical committees and well as revisions of a number of standards previously approved. We also formally welcomed into membership the NECs of **Ethiopia**, **Guinea Conakry**, **Zimbabwe and Tunisia**, and returning member **Senegal**, which have joined AFSEC since the previous GA in 2016.

# 3<sup>rd</sup> Africa Smart Grid Forum Kigali – Rwanda 1-4 October 2018



The main forum brought together 204 participants, with delegates from some 31 countries, including 23 African countries: Algeria, Belgium, Burkina Faso, Cameroon, Canada, China, Côte d'Ivoire, DR Congo, Egypt, Ethiopia, France, Germany, Ghana, Guinea, India, Kenya, Lesotho, Malawi, Mali, Namibia, Nigeria, Rwanda, Senegal, South Africa, Tanzania, Uganda, United Kingdom, USA, Chad, Zambia, Zimbabwe.


The Exhibitors included State Grid Corporation of China (SGCC) from China, dVentus from Ethiopia, Cigre (based in France), IEEE (Based in USA), and several local Rwandese companies.

The forum featured some 35 presentations covering a wide range of topics and with participation from many international and local organizations: AFREC, AFSEC, AUC, CENELEC, dVentus (Ethiopia), EDF, Eskom, IEC, IEEE, HUAWEI, General Electric, Ghana Ministry of Energy, Landis+Gyr, NEPAD, RTE (France), State Grid Corporation of China, Rwanda Standards Board, Rwanda Convention Bureau, Rwanda Energy Group, Rwanda Ministry of Energy and Water


The main forum was preceded by several workshops and seminars on 1<sup>st</sup> and 2nd October, including the AFREC Seminar on energy efficiency and meetings of several AFSEC technical committees. Other highlights of this forum were the acceptance of Hon. Germaine KAMAYIRESE the then Minister of State

in Charge of Energy and Water, Rwanda, to be AFSEC's Ambassador, and the publication of the AFSEC Guide for the application of standards for smart metering in Africa.

# IEC General Meeting - Busan, South Korea 22-26 October 2018





As has become the usual practice, bilateral meetings with CENELEC, DKE Germany and IEC were held on the side of the IEC GA held in Busan, South Korea. We identified a number of areas and potential activities. We also took the opportunity to have side meetings with representatives of ANSI and IEEE, with the expectation to conclude cooperation agreements in 2019. A special meeting with the President of State Grid Corporation of China was arranged, where Dr Shu made commitments to continue to support AFSEC's development. His election of President Elect of IEC was subsequently endorsed during the IEC GM, giving further weight to the assurance of continued high level support for AFSEC at the level if the IEC. Delegates from many AFSEC National Committees also attended the IEC GM.

# **Special General Assembly 2019**

As resolved at the 6<sup>th</sup> General Assembly in July 2018, a special General Assembly with be held in Cairo Egypt in mid-2019: The proposed dates 16-18 July 2019. The significance of this special GA will be the election of the AFSEC President for the term 2020-2023, to succeed KOUTOUA Claude who has served in that capacity since 2008. Also the election for treasurer to succeed Dr Eldestawy in 2020, and several positions of technical committee chairmen.

#### **Relocation of AFSEC secretariat to Cairo**

Eng Omneya Sabry will take over the role of Executive Secretary and head of the AFSEC secretariat as from 1 January 2019. The headquarters relocates to Cairo: the offices are located at 1 Eng. Maher Abaza Street, 2<sup>nd</sup> Floor, behind Elseka Elhadid Club, Nasr City, Cairo.

Initially Eng. Sabry will be supported by in Cairo by Rawda Elfarmawy and Mohamed Adel amongst others, while the contracted services of van der Walt & Co in South Africa will continue until such time as all support services and financial systems are operational in Cairo.
