#### Signed Memorandum of Understanding -MOUs

A bilateral meeting of Task Force Africa between AFSEC and EU Partners took place in Shanghai October 2019, ended up by signing a Copyright Declaration between AFSEC and CEN-CENELEC that mainly enables AFSEC access to CENELEC standards for review.

MOU between AFSEC and IEEE was signed in November 2019 between AFSEC and IEEE-SA. The MOU includes the capability of accessing Standards with watermark copy, supporting some AFSEC events, the recommendation of Experts as well as providing training on IEEE Standards.




#### **Upgrade of AFSEC Collaboration Platform:**

AFSEC Collaboration Platform was upgraded and launched in cooperation with IEC and is now available for AFSEC Committees to discuss, share and follow up their work with committees' members (MC, SMC, CAC and 6 TC). All AFSEC members were introduced to this platform by AFSEC Secretariat.

#### **AFSEC 7th General Assembly Virtual Meeting**

Both AFSEC 7th Meeting on 19-20 November 2020, and the 10th AMC Meeting on 18 November 2020, were virtually held because of Covid 19 Pandemic. In addition to the Election of Six Regional Representatives (2021-2023), some Technical Committee Chairs (2021 – 2023) and one Conformity Assessment Member (2021 – 2026), other important resolutions were approved, notably the Communication/Marketing Strategy, the Adoption of 3 Guides (one of them was already published in 2018), the adoption of 35 recommended standards, the upgrading of AFSEC Website and the selection of AFSEC financial Auditor for the term 2020 to 2022.
